



## VOLUNTEER RELEASE AND WAIVER

As a volunteer, I will provide various services for Kitchens For Good related to its mission to break the cycles of poverty, hunger, and food waste.

I, \_\_\_\_\_, understand that the scope of Volunteer's relationship with Kitchens For Good is limited to a volunteer position and that no compensation is expected or will be provided in return for services provided by Volunteer. I understand and acknowledge that I am not in an employment or any other contracted or service provider relationship with Kitchens For Good other than on a volunteer basis. Kitchens For Good will not provide benefits traditionally associated with employment by Kitchens For Good. I further agree and acknowledge that I am responsible for my own insurance coverage in the event of personal injury, accident, illness or any other event requiring medical or health treatment as a result of Volunteer's services to Kitchens For Good.

**1. WAIVER AND RELEASE:** I, the Volunteer or Parent/Guardian, release and forever discharge and hold harmless Kitchens For Good and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from the services I provide to Kitchens For Good. I understand and acknowledge that this Release discharges Kitchens For Good from any liability or claim that I may have against Kitchens For Good with respect to bodily injury, personal injury, illness, death, or property damage that may result from the services I provide to Kitchens For Good or occurring while I am providing volunteer services.

**2. NO RIGHT TO COVERAGE FROM KITCHENS FOR GOOD:** Further, I understand that Kitchens For Good does not assume any responsibility for or obligation to provide me with compensation, remuneration or any other financial assistance, including but not limited to medical, health or disability benefits or insurance of any nature in the event of my injury, illness, death or damage to my property. I expressly waive any such claim for compensation or liability on the part of Kitchens For Good.

**3. NO CLAIMS FOR MEDICAL TREATMENT:** I hereby Release and forever discharge Kitchens For Good from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my tenure as a volunteer with Kitchens For Good.

**4. ASSUMPTION OF RISK:** I understand that the services I provide to Kitchens For Good may include activities that may be hazardous to me including, but not limited to operation of kitchen appliances, use of kitchen instruments, use of cleaning products, operation of a motor vehicle, and other work involving inherently dangerous activities. As a volunteer, I hereby expressly assume the risk of injury or harm from these activities and Release Kitchens For Good from all liability for injury; illness, death or property damage resulting from the services I provide as a volunteer or occurring while I am providing volunteer services.

**5. PHOTOGRAPHIC RELEASE:** I grant and convey to Kitchens For Good all right, title, and interests in any and all photographs, images, video, or audio recordings of me or my likeness or voice made by Kitchens For Good in connection with my provision of volunteer services to Kitchens For Good.
